3. Not all insurance companies cover you for emergency medical or dental care onboard foreign ships, international waters, overseas or foreign countries or outside the USA in general. All Genre Travel recommends and offers travel insurance to cover emergency medical, dental and to trip cancellation to protect nonrefundable amounts should you have to cancel. An insurance quote can be given with invoice receipt after booking and can be added at any time before sailing.
4. It is the passenger's responsibility to read the Cruise Passenger Ticket Contract on the cruise line website.
5. We are a large group of people on a regular sailing with nongroup members. Although the cruise line waives many policies for us, we must always strive to be respectful of other guests and crew.
